1. Flight July 6, 2017 – Detroit to Chicago: I am identified for additional screening
  - a. TSA full body search
  - b. Thorough search of carry-on
2. On continuing flight Chicago to Amsterdam – same day
  - a. Two airline service personnel check my passport
  - b. They inform me that I am in the system as a “Deportee”
3. Return flight July 12, 2017 – Amsterdam to Chicago and Chicago to Detroit: Use of wheelchair
4. Advised to contact USDHS – TRIP – Travelers Redress Inquiry Program
  - a. I submit DHS Travelers Inquiry Form
  - b. Receive a Redress Control Number
5. Two weeks later, DHS TRIP case status is “In Process”
6. Two weeks later, DHS TRIP case status is “Closed”
  - a. Letter from DHS states “Your experience was most likely caused by a misidentification against a government record or by random selection”
  - b. “Provide your redress control number in the future”
7. Attorney advises that I get resolution at USCIS
8. Meeting at USCIS on Sept. 14, 2017
  - a. “You have no A number”
  - b. “We have to contact CIS in New York for your file”
9. No further follow-up by USCISA to date.
